

Frequently Asked Questions



REGISTRATION

01 If I participated in a previous edition, should I register for the 2021 edition?

Yes, we strongly recommend that you participate in the new edition as part of your ongoing professional development. Here is what's new in the third edition:

- All levels
- New themes
- The possibility of experimenting and exchanging with trainers in small groups during certain online workshops
- Ideas for simultaneously managing students remotely and in person
- The opportunity to attend a HyFlex (Hybrid-Flexible) workshop and get inspired

02 Who is Digital Education Day intended for?

The day is mainly intended for teachers, education consultants and school administrators in the public and private education sectors as well as Indigenous organizations. Workshops for different levels (beginner, intermediate and advanced) will be offered.

03 Do I have to register to attend the workshops?

Yes, you must register to receive the login link and participate in the workshops. Some workshops have a limited number of places.

04 How much does registration cost?

The DED training event, organized by the Ministère de l'Éducation, is free of charge for participants.

05 Do I have to register before November 5 to access the workshop recordings?

You do not have to register to gain access to the workshop recordings after November 5. The conference-type workshops will be available on the Ministère's YouTube channel starting November 10.

06 Can I attend only one workshop during the training day?

Yes, you can choose one or more workshops according to your availability and interests.

PARTICIPATION

07 If teachers have to be released from teaching duties to participate in this day, does the organization pay for the supply teacher?

Participation in Digital Education Day is eligible for the budget measure for the continuing education of teachers, upon approval of release by your school's administration.

- Public sector: Measure 15084
- Private sector: Measure 30150

08 Can this participation count as continuing education?

Yes, this professional development activity can be included in your continuing education plan, regardless of whether you participate in real time or if you watch the recordings later.

09 Is a confirmation of registration required to access the streaming site and activities?

A confirmation of registration is not required to access the streaming site. Only the address given during registration will be needed.

10 Will the people registered receive a link to connect to the streaming site?

Registered participants will be sent a link to the work email provided at registration, two weeks prior to the event and again as a reminder the morning of the event.

11 Can I connect to a workshop using a co-worker's link?

No, each participant must use their work email to log in to the event.

ORGANIZATION

12 What streaming site will be used to attend the workshops?

Details regarding the streaming site will be provided on October 12.

13 Will I be able to interact with the trainers?

Some workshops, by registration only and with limited space, will offer activities that allow for more interaction between trainers and participants. For other conference-type presentations, participants will be able to ask questions in the chat.

14 Will some workshops be offered in English?

All workshops are in French, but simultaneous translation will be available for some conference-type workshops. You can see which ones in the program.
