I am the holder of a provisional teaching authorization for vocational training; I am completing a Bachelor of Education in vocational training; and :

- I am requesting a renewal for a first period of three school years (I have earned at least 15 credits in teacher training in my teacher training program, excluding those granted in recognition of knowledge acquired through practising the occupation).
- I am requested a renewal for a second period of two school years (I have earned at least 39 credits in teacher training in the same teacher training program, no more than nine credits of which were granted in recognition of knowledge acquired through practising the occupation).
- I am requesting a renewal for a final period of two school years (I have earned at least 63 credits in teacher training in the same teacher training program, no more than nine credits of which were granted in recognition of knowledge acquired through practising the occupation, not including those that were counted for the second renewal).

C- Documents that the candidate must attach (section 40 of the *Regulation respecting teaching licences*)

- Certified copy of the university transcript attesting that the candidate has earned the credits required to successfully complete a vocational teacher training program.
- [Declaration Concerning a Judicial Record](#) (section 25.1 of the *Education Act*) available on the Ministère Web site.
- Certified copy of the candidate's certificate of Canadian citizenship, permanent resident document, work permit or Québec certificate of acceptance authorizing the candidate to work in Québec, if these documents have not already been provided.

If certified copies cannot be provided and the candidate presents valid reasons why, the Ministère may, exceptionally, accept sworn copies.

This information may also be used for research or statistical purposes. It is treated confidentially and is accessible only to authorized staff who need it to carry out their duties.
